INVITATION TO BID

Notice is hereby given that the Petersburg Borough will receive sealed bids for the PMP&L Retaining Wall Project ~ 2017. The project generally consists of a Base Bid. The Base Bid Work generally consists of demolition of existing concrete retaining walls, sidewalk & curb/gutter. Construction of new concrete retaining wall, new sidewalk, curb/gutter, and patching of street pavement.

The estimated construction cost for the base bid is approximately \$50,000. All Work must be completed by May 1, 2018.

Sealed bids will be received by the Petersburg Borough, Post Office Box 329, Petersburg, Alaska 99833, located upstairs in the Municipal Building, 12 South Nordic Drive, Petersburg, Alaska 99833 until 2:00 p.m. prevailing time on October 2, 2017 at which time the bids will be publicly opened and read aloud in the Assembly Chambers.
