## OPPORTUNITY TO COMMENT STREAM RESTORATION USING HAND TOOLS

The Petersburg and Wrangell Ranger Districts propose to implement instream and floodplain restoration on Class I (anadromous) streams most commonly supporting populations of pink salmon (Oncorhynchus gorbuscha), chum salmon (O. keta), coho salmon (O. kitsuch), steelhead (O. mykiss), coastal cutthroat trout (O. clarki clarki), Dolly Varden char (Salvolinus malma), and in some cases king salmon (O. tshawytscha); and Class II (resident fish) streams supporting populations of coastal cutthroat trout and Dolly Varden char. The goal of this project is to improve instream and floodplain function by restoring key pieces of wood to the channel and floodplain of streams previously impacted by previous logging and road construction activities.

## How to Comment and Timeframe

Individuals and organizations wishing to be eligible to object must meet the information requirements of 36 CFR 218 Subparts A and B.

It is the responsibility of persons providing comments to submit them by the close of the comment period. Only those who submit timely and specific written comments regarding the proposed project during a public comment period established by the responsible official are eligible to file an objection under §218.

Written, facsimile, hand-delivered, and electronic comments concerning this action will be accepted for 30 calendar days following the publication of this notice in the Petersburg Pilot. The publication date in the newspaper of record is the exclusive means for calculating the comment period for this analysis. Those wishing to comment should not rely upon dates or timeframe information provided by any other source. The regulations prohibit extending the length of the comment period.

For objection eligibility each individual or representative from each entity submitting timely and specific written comments regarding the proposed project must either sign the comments or verify identity upon request.
