Commercial sales will be offered in areas previously approved through environmental reviews under the National Environmental Policy Act (NEPA).

Harvest may include green trees using uneven-aged management and may include the removal of dead and dying trees proposed by a Prospective Purchaser and/or Permittee. All areas will be reviewed by District Resource Specialists and approved by the District Ranger.

- Small sales and microsales maximum size is 50,000 Board Feet (50 MBF) and/or \$10,000 in advertised value.
