The project generally consists of the installation a new 8" PVC sanitary sewer main (approx. 1045 l.f.) to replace an existing sewer main. This will include the installation of 4 new manholes, modify 2 existing manholes and the removal and disposal of 3 existing manholes. Reconnect 11 existing sewer and water services. Also install 164 l.f. of 12" culvert and grade main roadway and existing driveways.

The estimated construction cost for the base bid is between \$200,000 & \$300,000. All Work must be completed by October 31, 2019.
