The project generally consist of the construction for sidewalks and storm water sewers along 12th Street, Howkan Street and 13th Street in Petersburg, Alaska. The project will be in three parts: base bid, additive item #1 & additive item #2. The bid will be awarded with base bid alone or base bid with a combination of additive bid items, either item or both. Base bid is approximately 1040 linear feet of sidewalk, with approximately 710 linear feet of storm water sewer. Additive bid item #1 is approximately 555 linear feet of sidewalk, with approximately 540 linear feet of storm water sewer. Additive bid item #2 is approximately 330 linear feet of sidewalk, with approximately 200 linear feet of storm water sewer.
