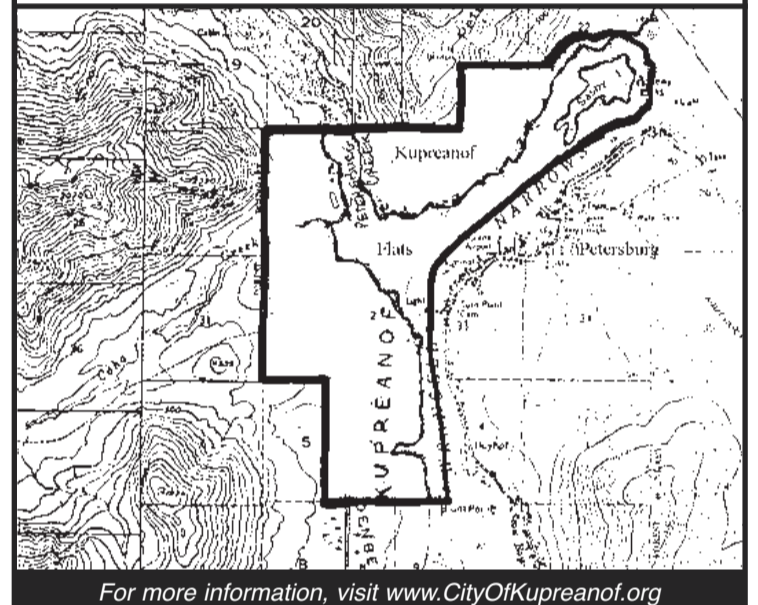

Provisions of Emergency Ordinance #2021-19 take effect immediately and will continue in effect until December 6, 2021 at 11:59 p.m. unless earlier repealed by the Assembly.
