

NOTICE IS HEREBY GIVEN, pursuant to Alaska Statute 29.45.440 and Section 4.24.440 of the Petersburg Municipal Code, that the redemption period for the properties listed in Exhibit "1" of the Judgment and Decree entered on November 22, 2019 by the Superior Court for the State of Alaska, First Judicial District at Petersburg (Case No. 1PE-19-55 Civil), foreclosing on real property against which taxes are delinquent for the year **2018**, will expire on **December 14, 2020**. 

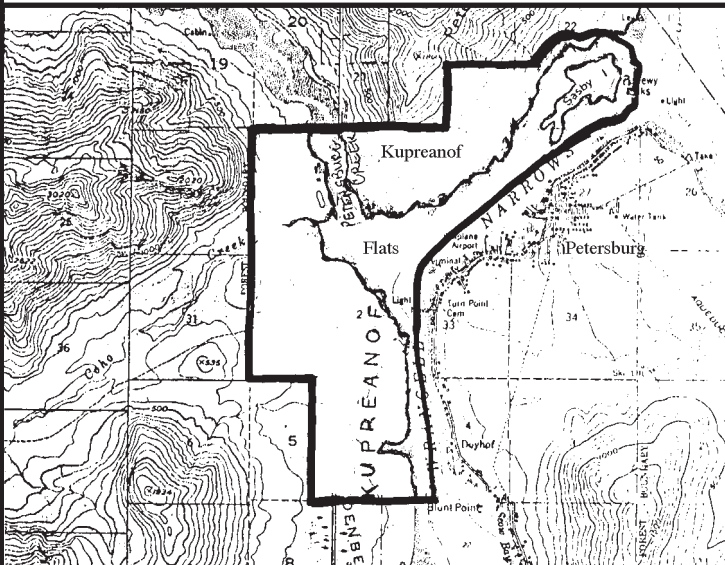
