You do not need a permit to cut a Christmas tree on the Petersburg Ranger District for personal use. Christmas tree cutting for personal use is not intended to sell for commercial use.
 There are no regulations on what tree species to cut or size to cut.
However, there are a few rules to follow:
 ❄️ Do not top a larger tree
 ❄️ Do not cut a tree and then discard it for another one you may find more desirable, and
 ❄️ Cut trees as close to the ground as possible, below the lowest limb or 12 inches from the ground.
